Moderate Islam: The Religious Foundation of the Muhammadiyah Movement in Indonesia

ABSTRACT

Islam as a doctrine capable of addressing every aspect of the community's issues, will continue to evolve with the times. Muslims are expected to be critical and to have a moderate conceptual framework in interpreting religious texts. This approach will inevitably influence individual movements and religious practices. Muhammadiyah, as one of the largest social organizations in Indonesia, has a deeply rooted religious movement that extends down to the grassroots. This article discusses the concept of moderation as a religious foundation that underpins the Muhammadiyah Islamic Movement in Indonesia. The research method employed is a literature review of the thoughts and teachings embraced by the Muhammadiyah Movement. help individuals physically but also build social concern and solidarity among communities. In the economic sector, Muhammadiyah is engaged in entrepreneurship empowerment by supporting the development of small and medium-sized enterprises (SMEs). We believe that community welfare and environmental sustainability are interconnected." Through development projects and environmental programs, Muhammadiyah aims to enhance the quality of life while preserving natural resources³⁴.

However, Muhammadiyah faces various challenges in the contemporary era, including pressure from extremist groups and political dynamics. Haedar Nashir points out, "In facing these challenges, Muhammadiyah must continue to reinforce its commitment to moderation and adapt to changing times. It is crucial to strengthen organizational capacity and adjust strategies to remain effective and relevant." This effort involves improving internal capacity, strengthening social networks, and adjusting missionary strategies and social programs to address contemporary issues³⁵.

Overall, Muhammadiyah as a moderate Islamic movement continues to make significant contributions to various aspects of Indonesian society, including education, missionary work, social services, economic empowerment, interfaith dialogue, social reform, infrastructure development, and environmental protection. With its inclusive and adaptive approach, Muhammadiyah is committed to advancing Indonesian society toward a better and more harmonious future.

From the perspectives of these experts and figures, we can see that Muhammadiyah's contribution to society and religion in Indonesia is extensive and diverse. Through various efforts in education, social services, advocacy for justice, and wise preaching, Muhammadiyah continues to be a force for positive impact in strengthening the nation's identity and advancing the welfare of the people. By understanding and appreciating these
