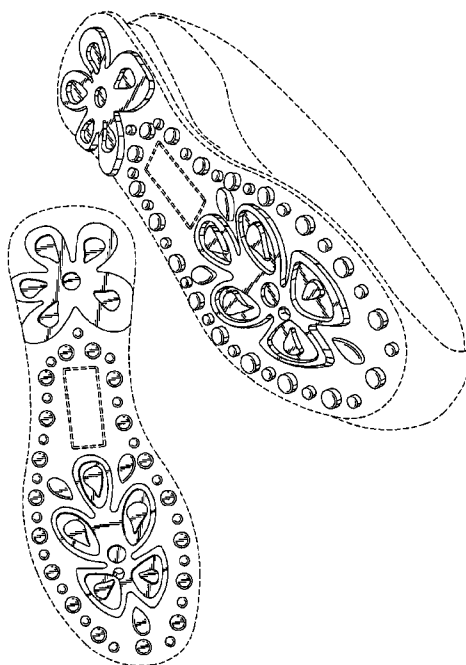
(57) **CLAIM**

A design for a portion of a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portion of a shoe outsole showing my new design; and, FIG. 2 is a bottom plan view thereof. The broken lines shown for the remainder of the sole and the shoe are for illustrative purposes only, and form no part of the claimed design.

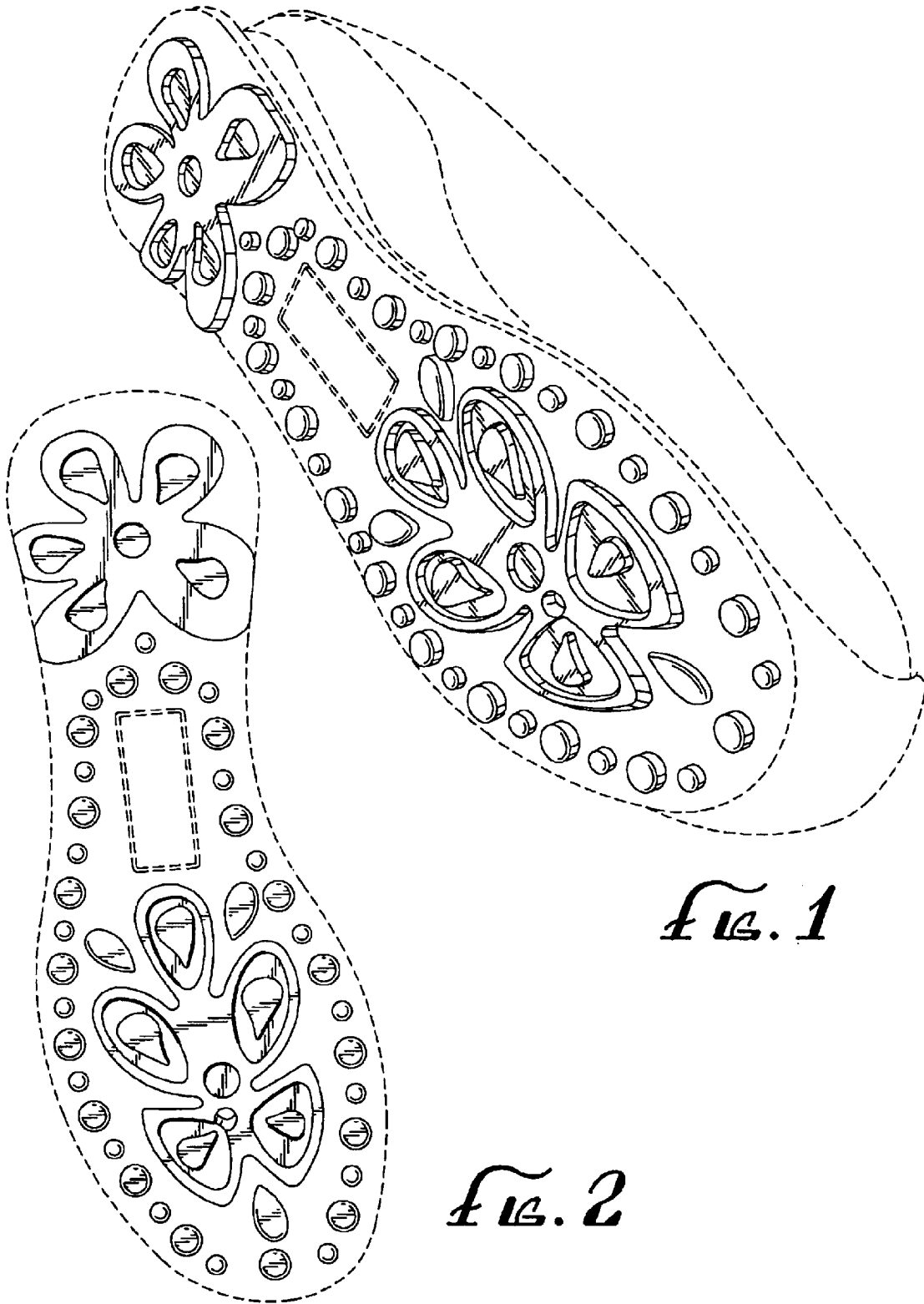
