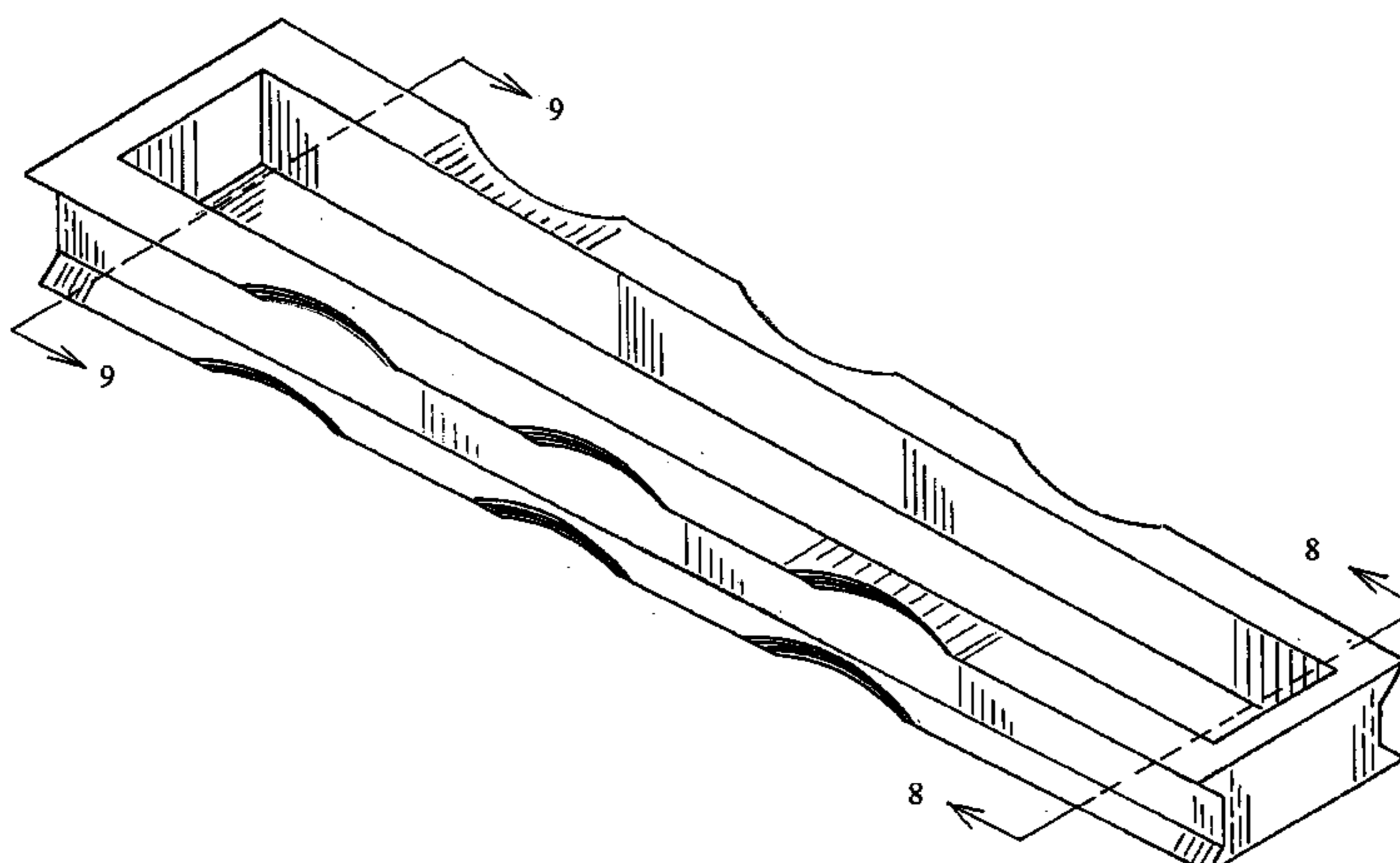
(57) **CLAIM**

I claim the ornamental design for socket containing device, as shown and described.

DESCRIPTION

FIG. 1 is a front side perspective view of a first embodiment of a socket containing device showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front-end view thereof; FIG. 5 is a back-end view thereof; FIG. 6 is a first side view thereof; FIG. 7 is a second side view thereof; FIG. 8 is a front-end cross-section taken along line 8-8 of FIG. 1; FIG. 9 is a back-end cross-section taken along line 9-9 of FIG. 1; and, FIG. 10 a front side perspective view of a second embodiment of a socket containing device showing my new design. The broken line showing of environmental subject matter is for illustrative purposes only and forms no part of the claimed design.

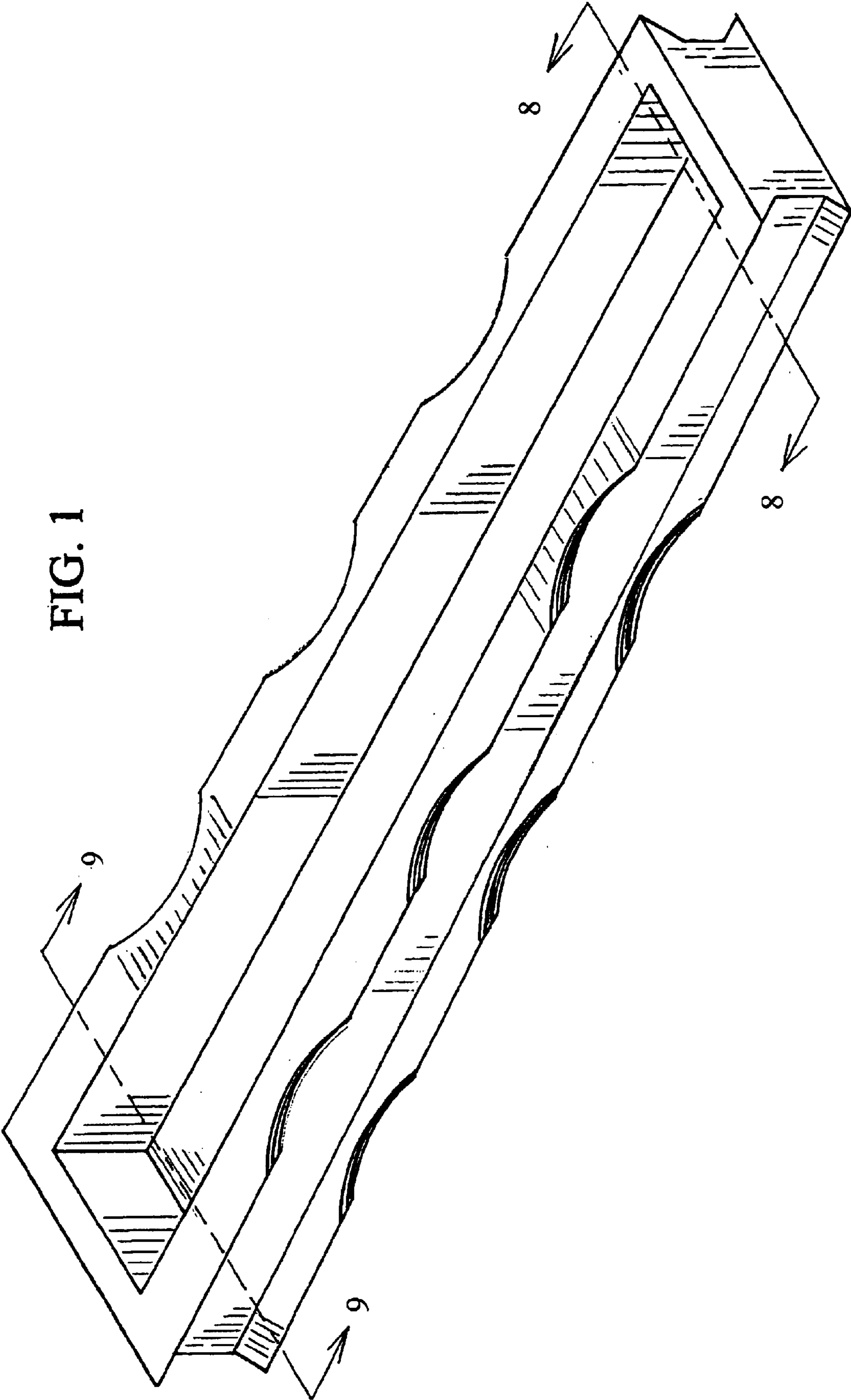

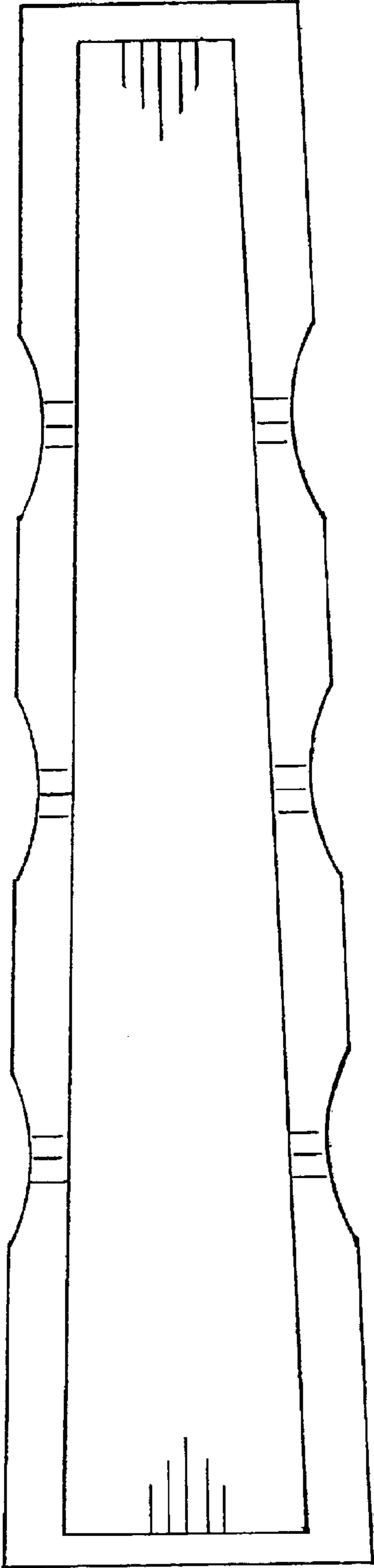

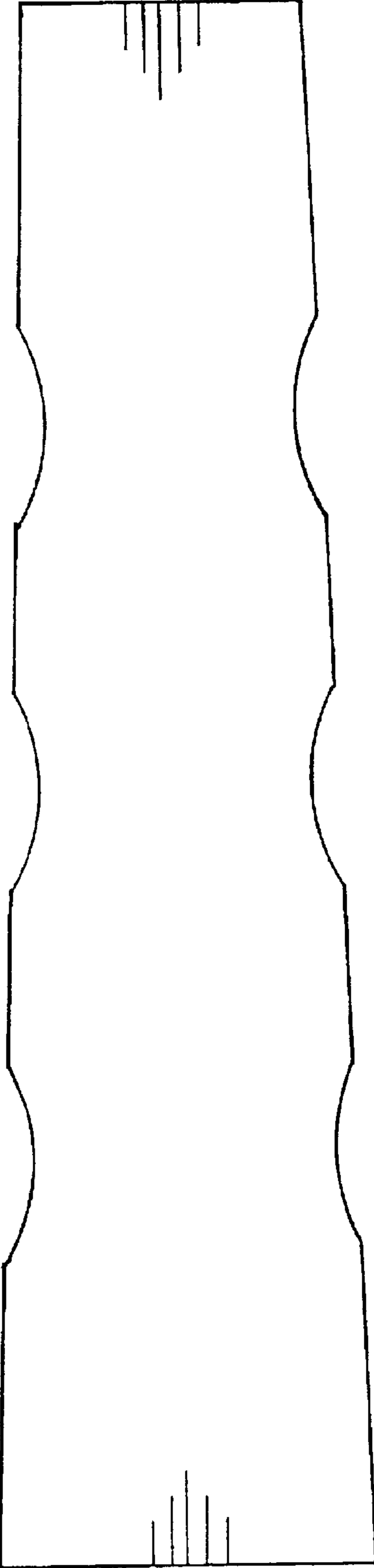

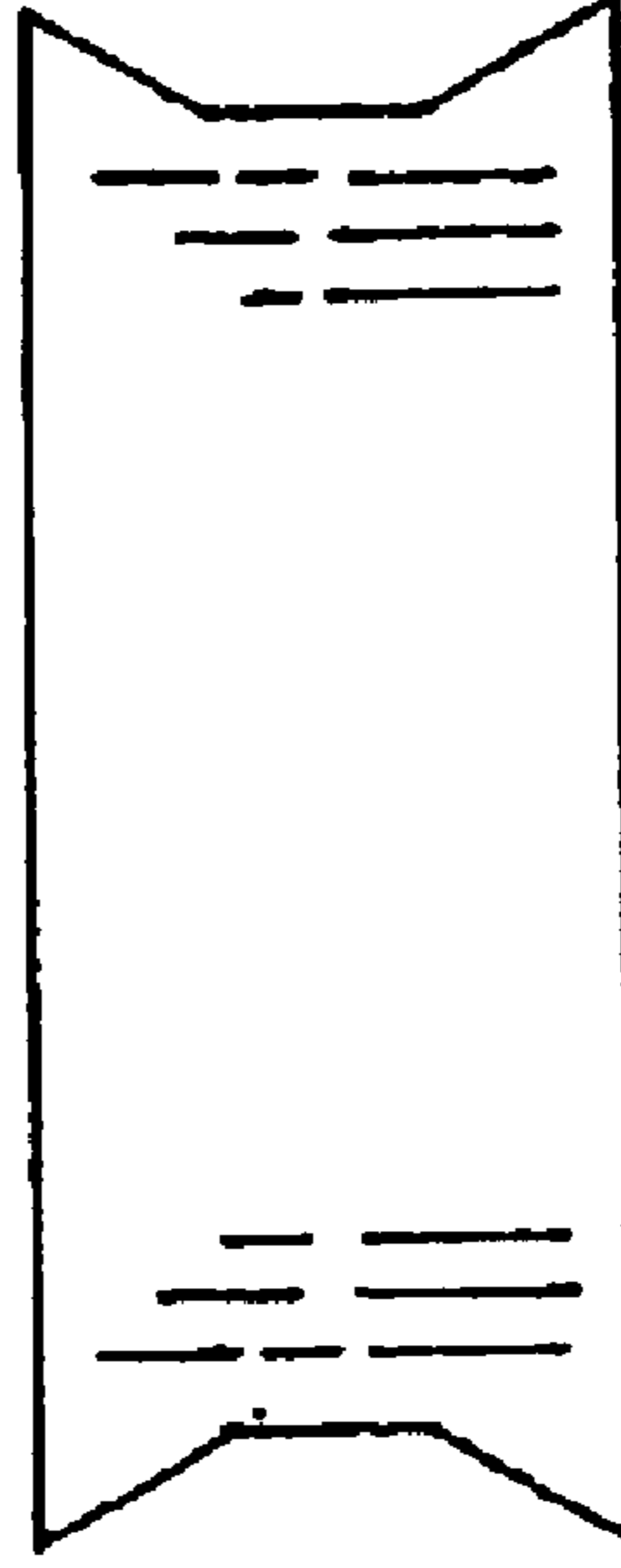

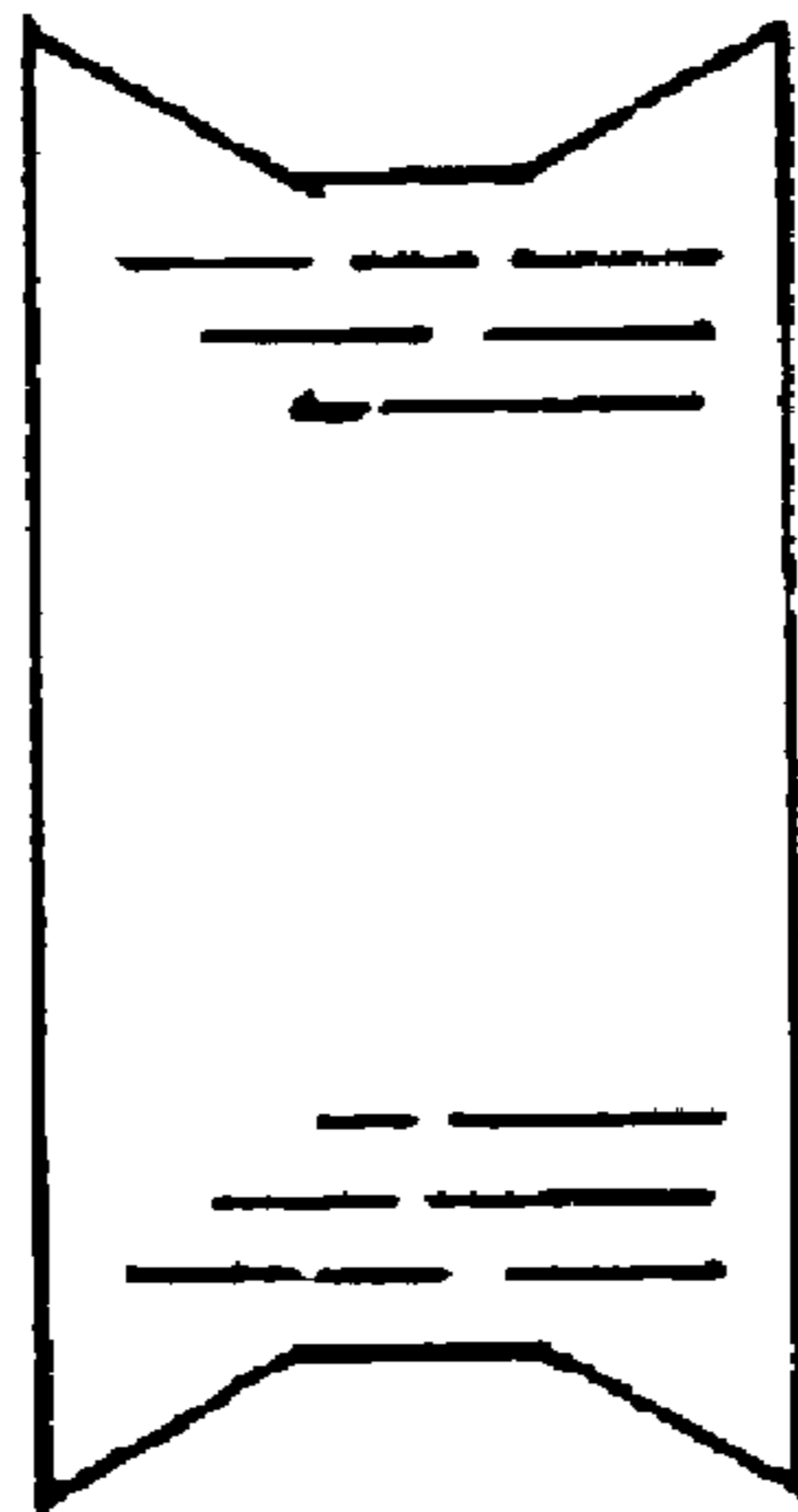

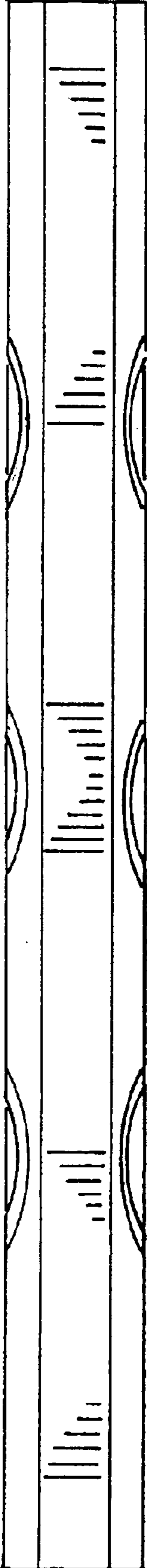

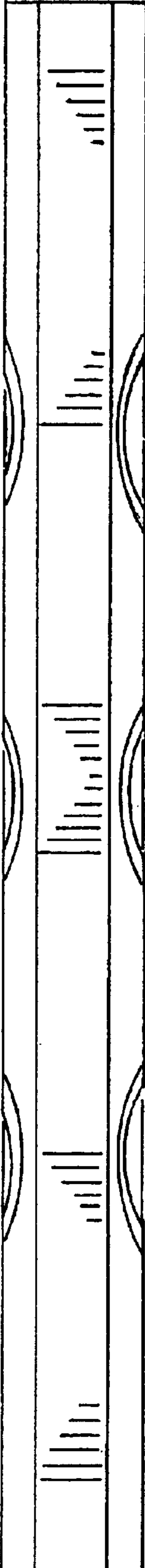
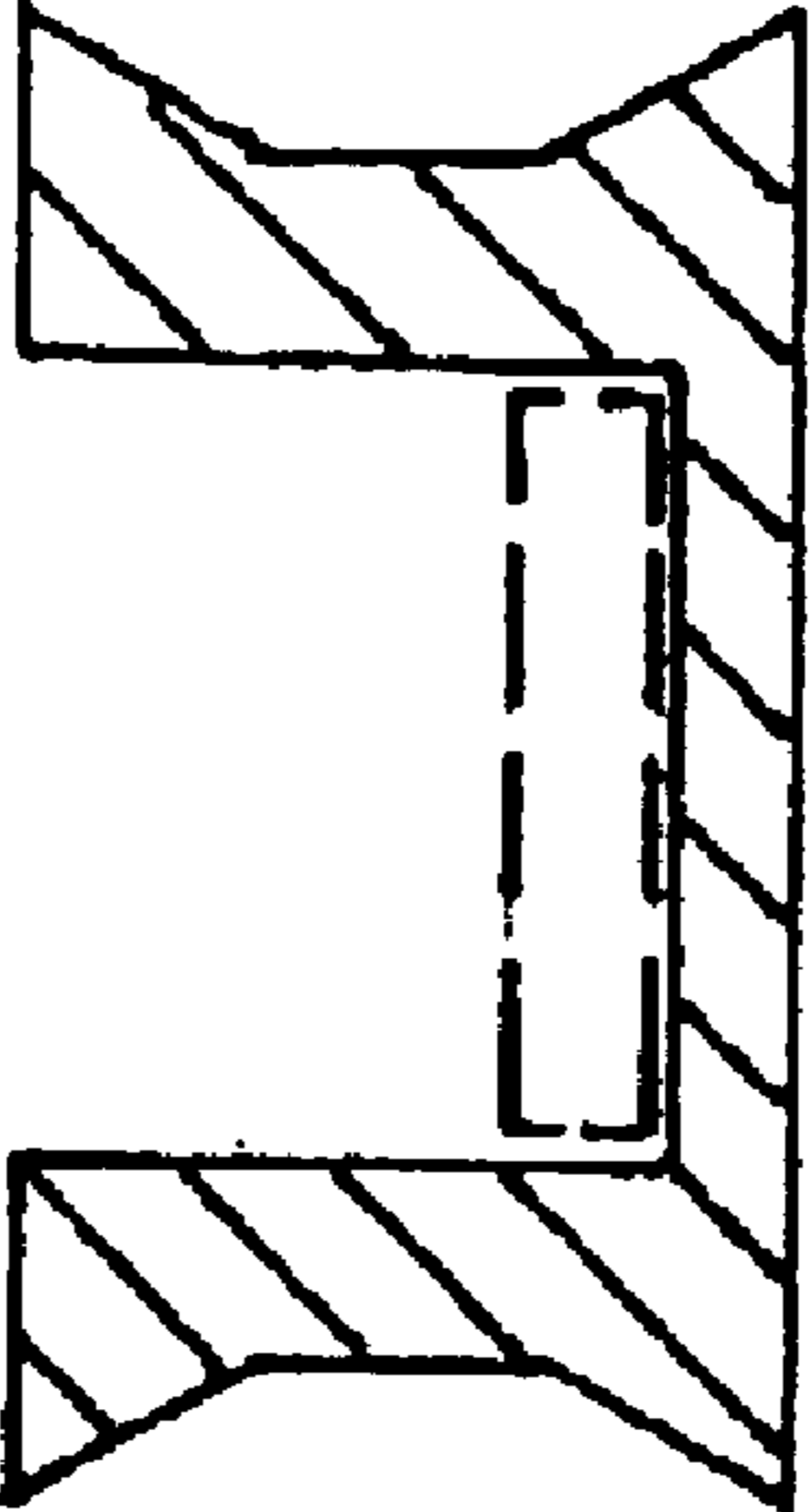

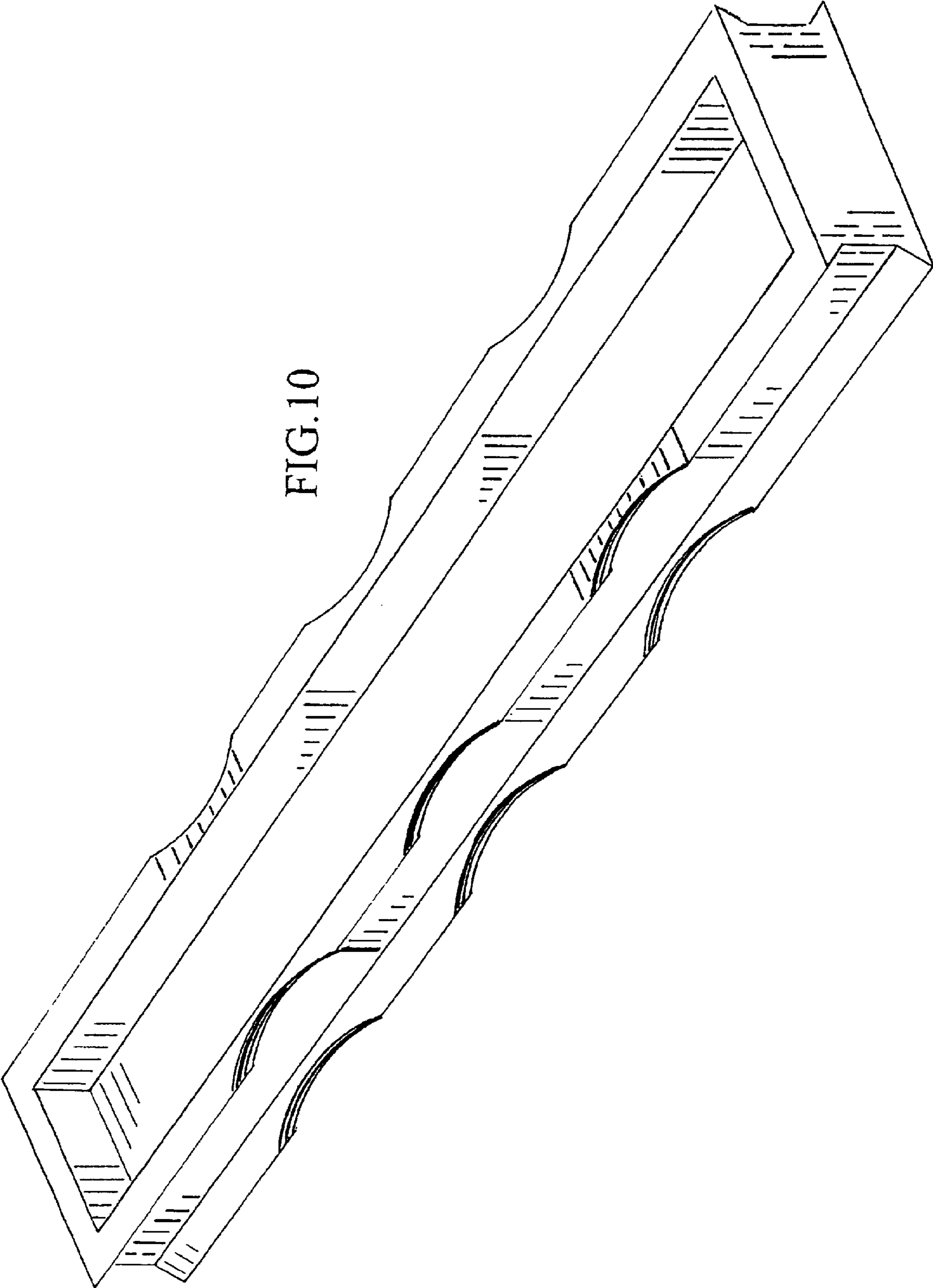
