**DESCRIPTION**

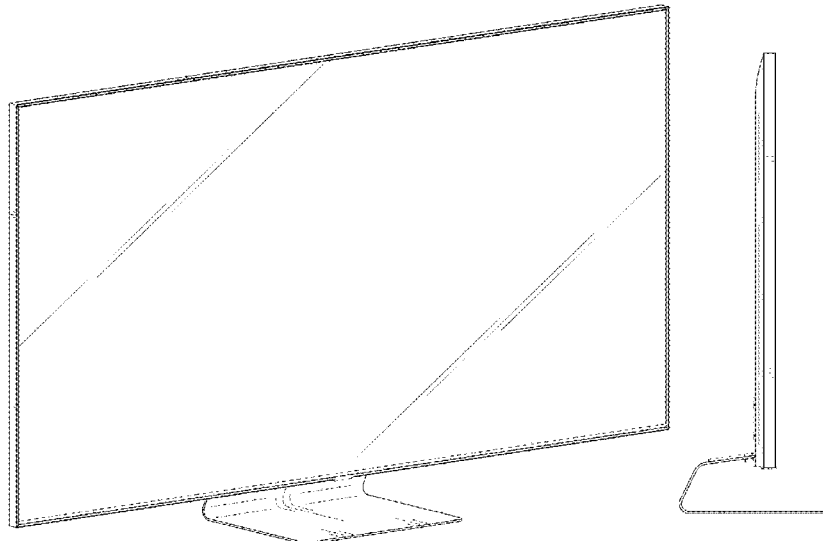
FIG. 1 is a front perspective view of a television receiver showing our new design;

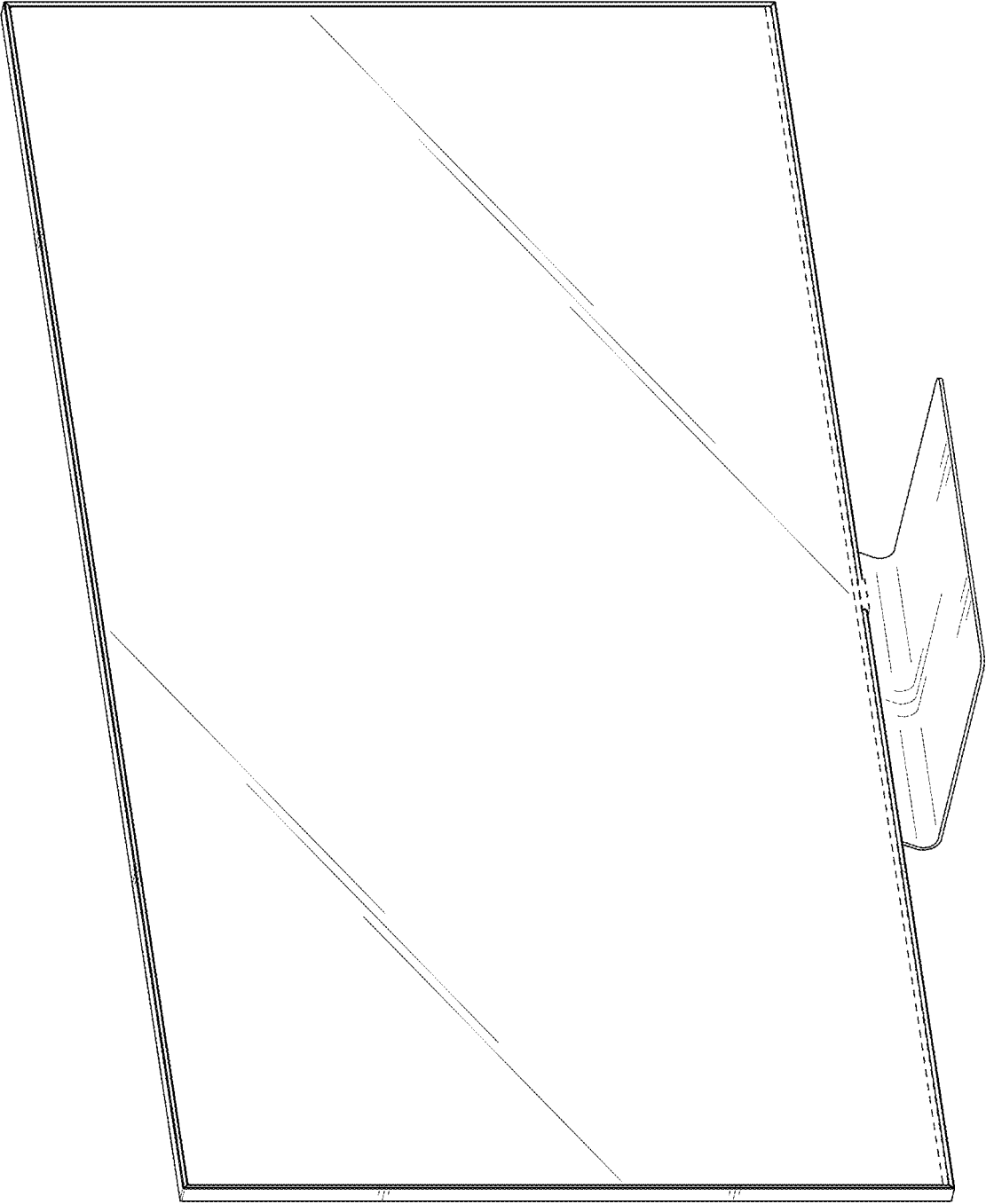

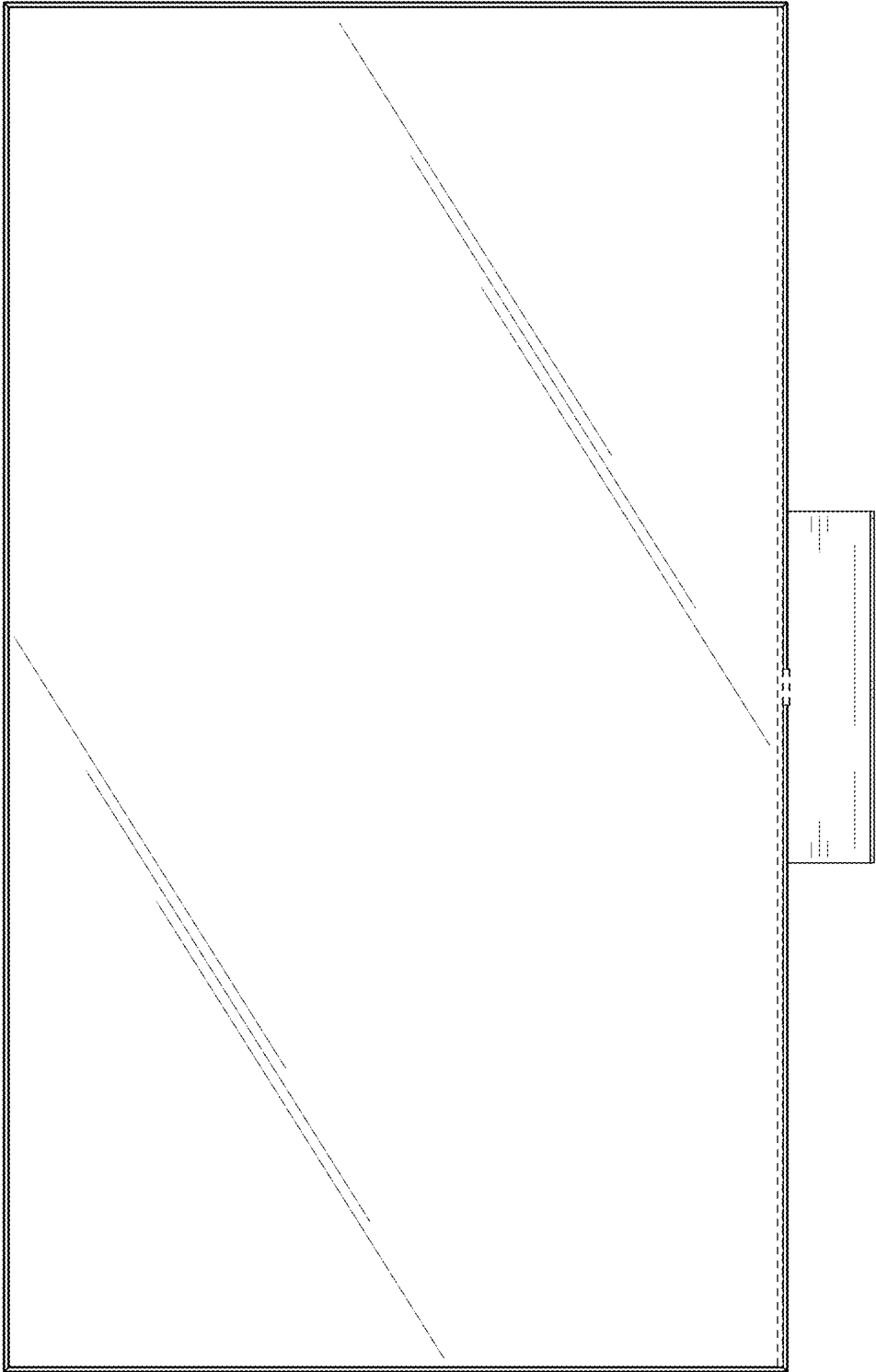

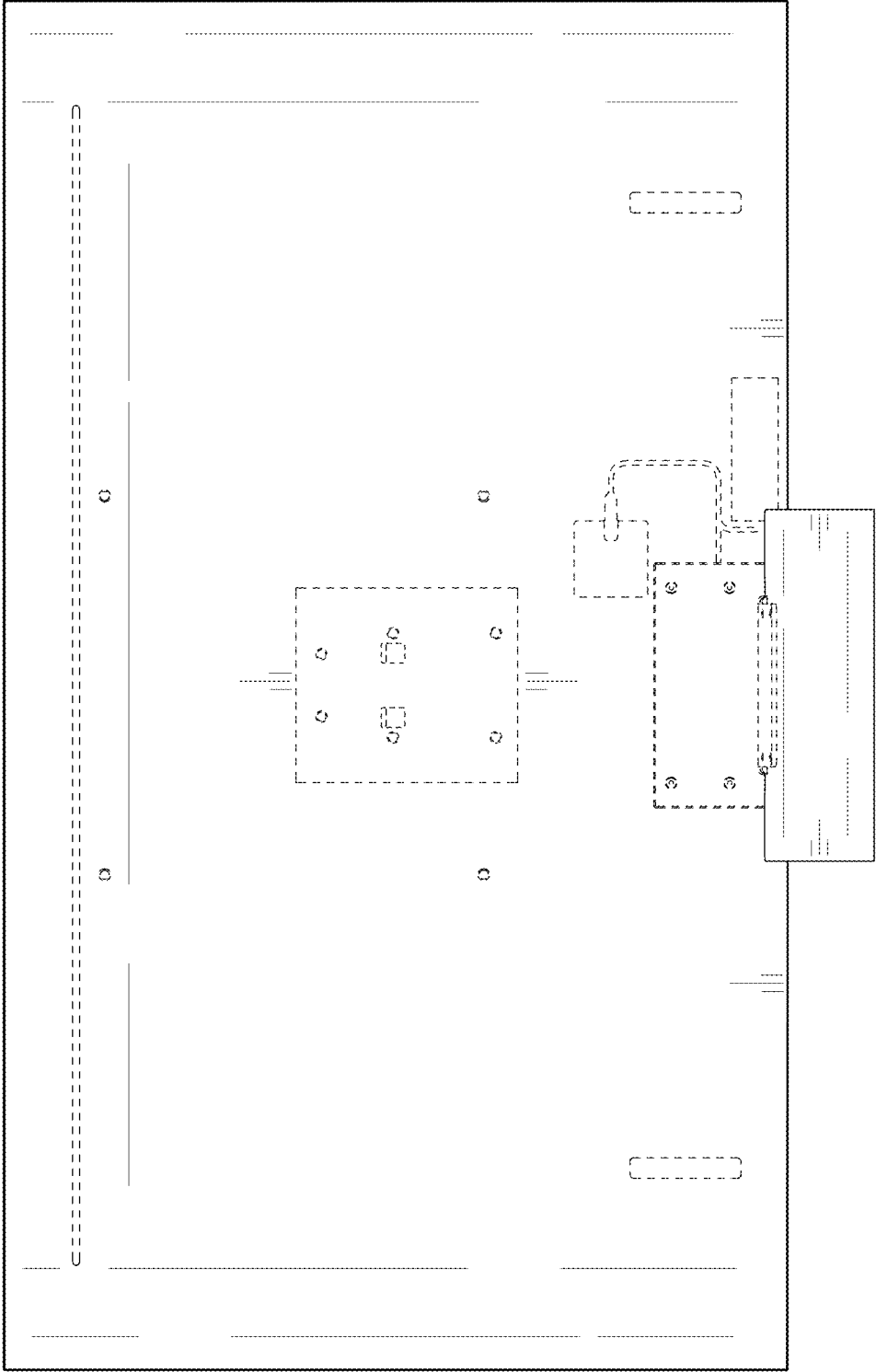

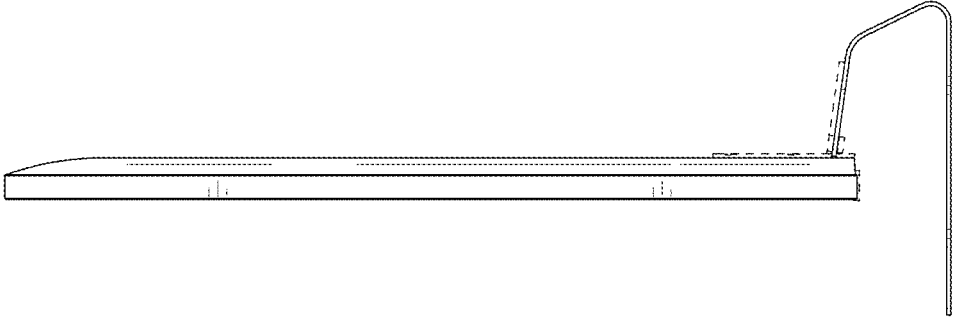

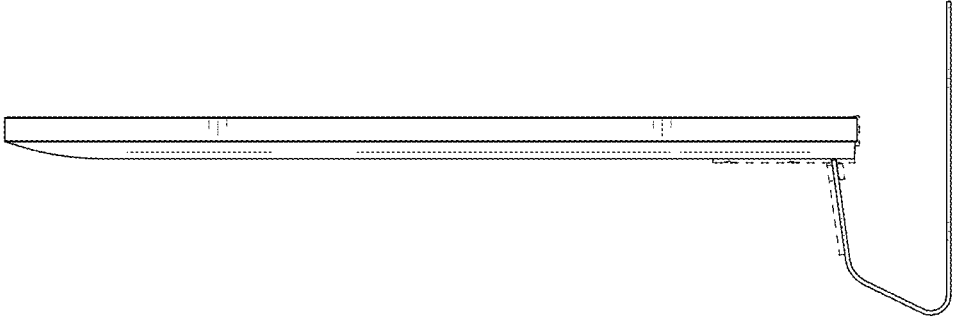

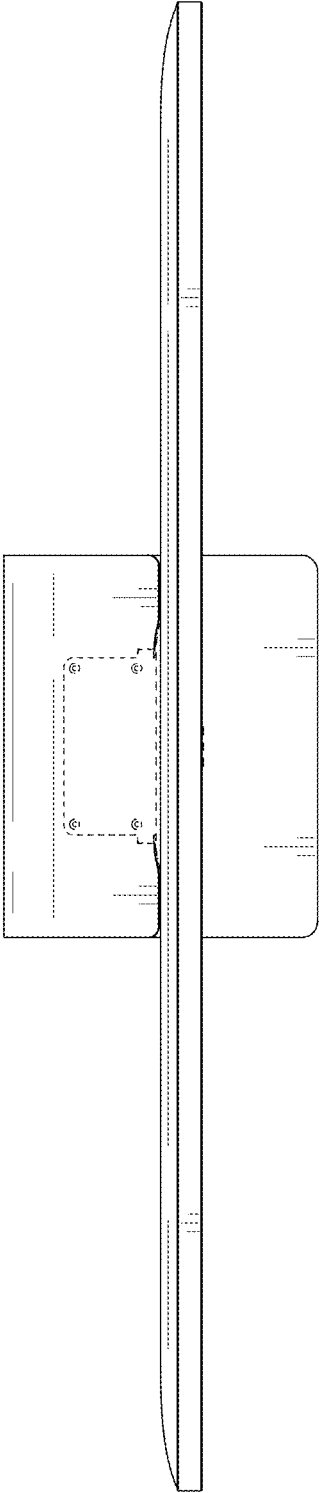

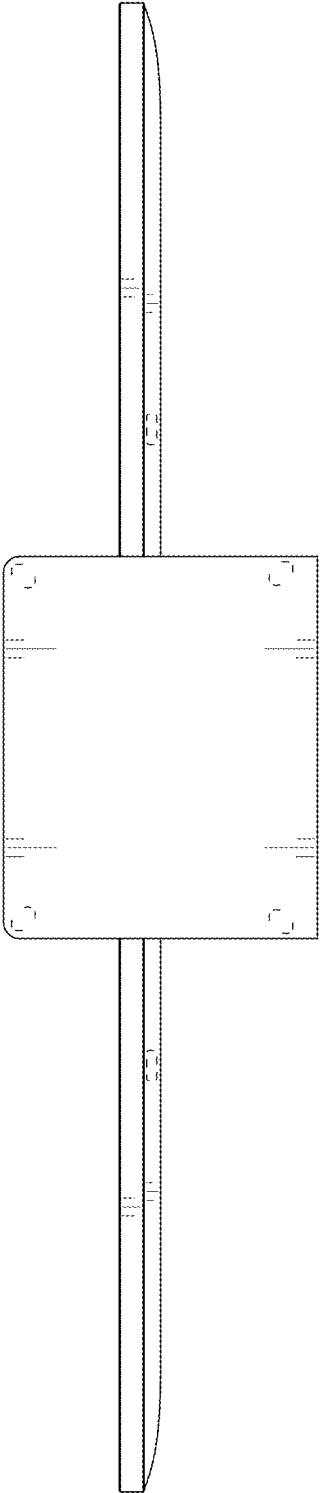
