(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of the present invention, shown in a right-foot orientation; a second embodiment being a left-foot orientation, which is a mirror image of the first embodiment.

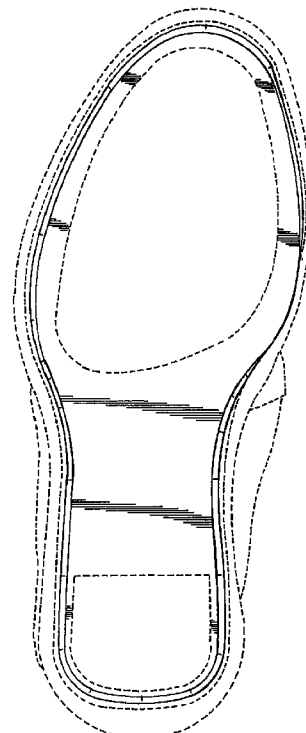
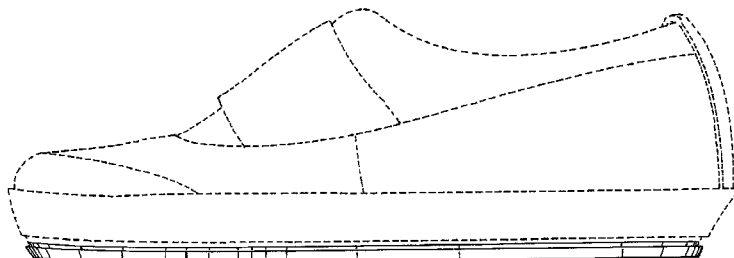
FIG. 2 is a left side elevation view of the embodiment shown in FIG. 1.

FIG. 3 is a right side elevation view of the embodiment shown in FIG. 1; and,

FIG. 4 is a bottom plan view of the embodiment shown in FIG. 1.

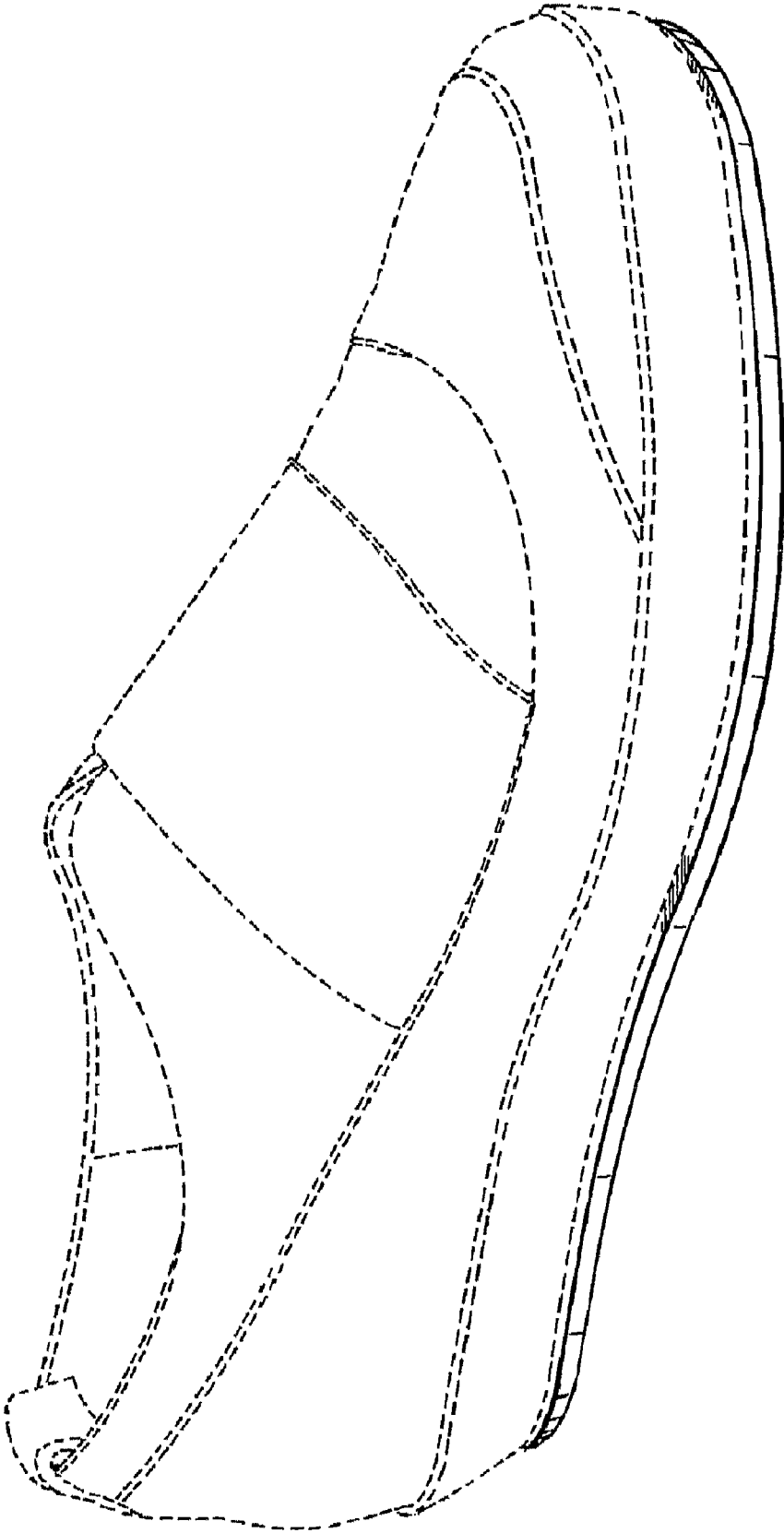

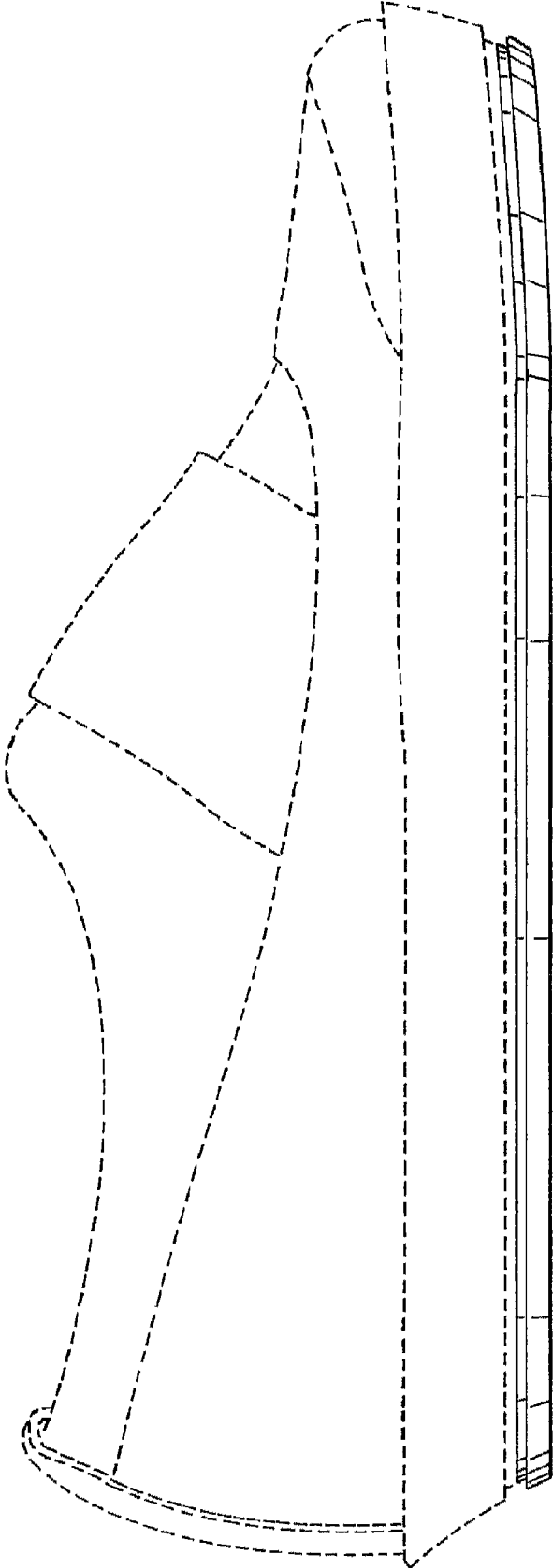

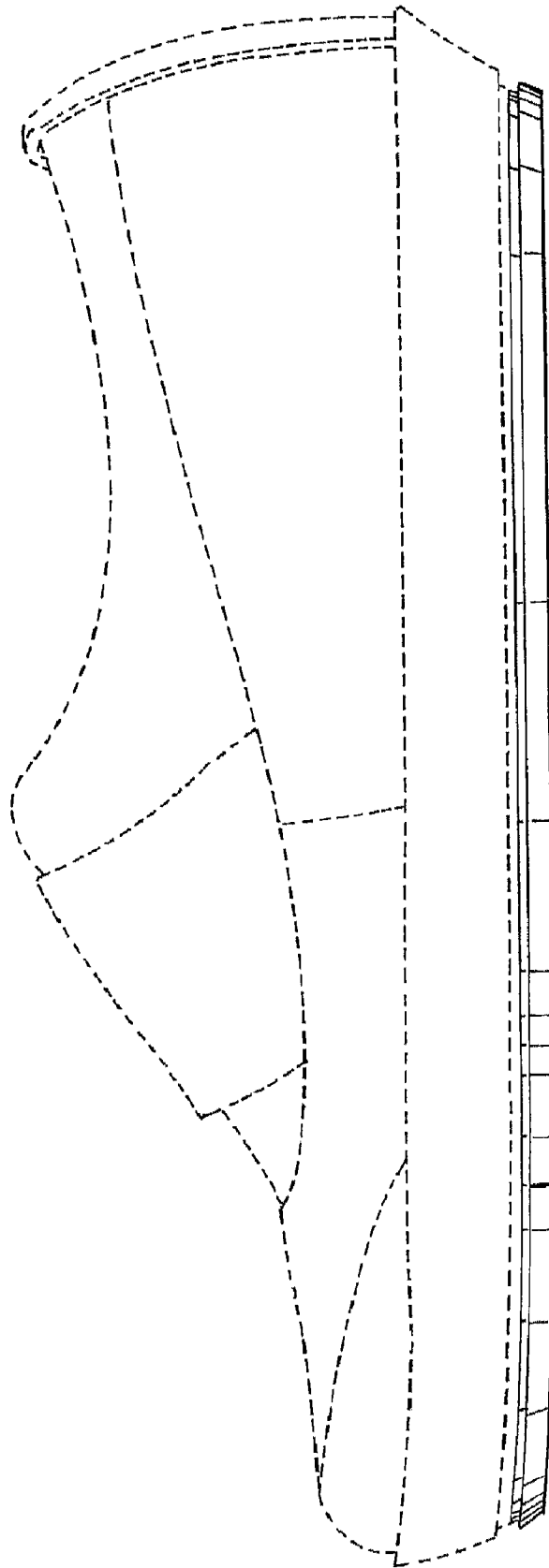

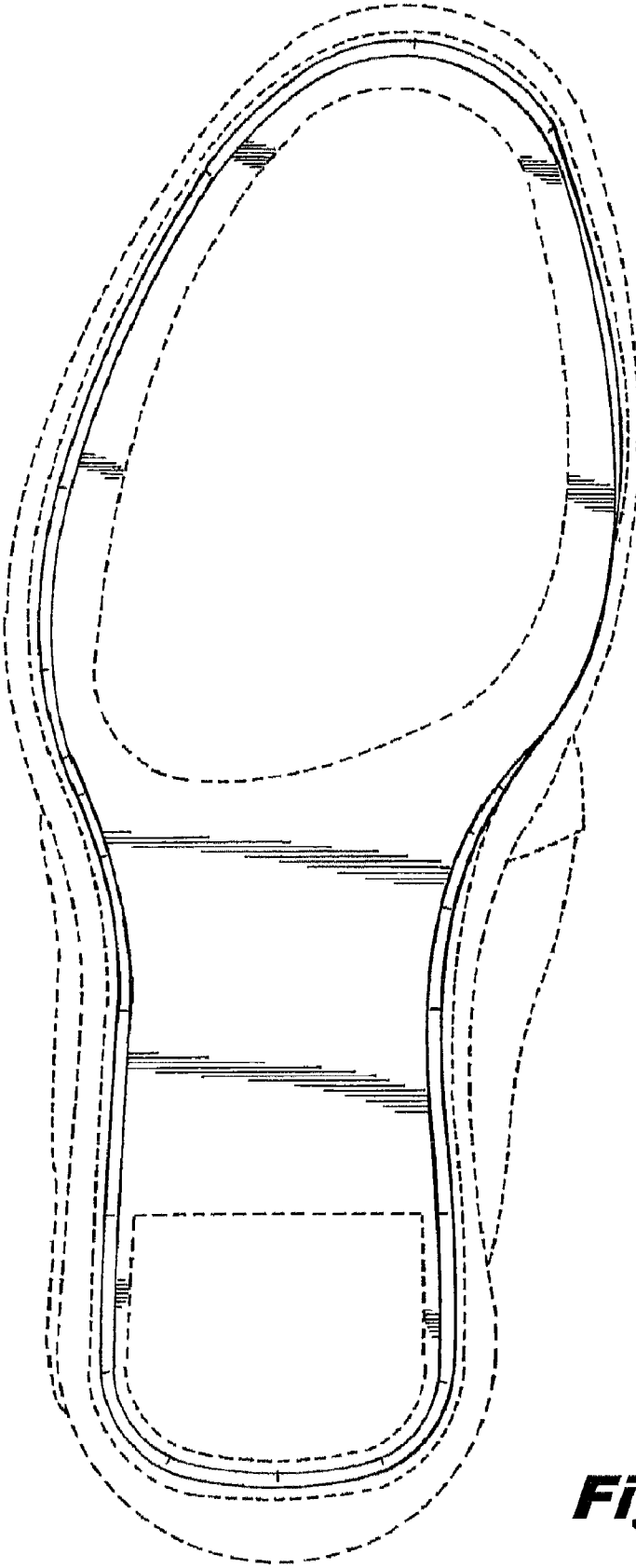
