(57) **CLAIM**

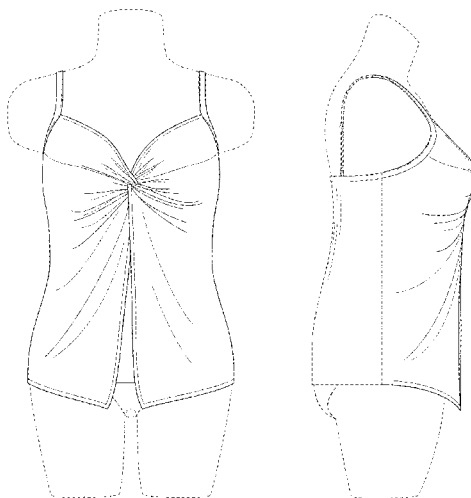
The ornamental design for a swimsuit, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a swimsuit showing the new design. FIG. 2 is a rear view thereof. FIG. 3 is a left-side view thereof; and, FIG. 4 is a right-side view thereof.

The broken line showing of a model is for the purposes of illustrating environmental structure and forms no part of the claimed design. The broken lines illustrating portions of the swimsuit form no part of the claimed design. The dot-dash broken lines define the bounds of the claimed design and form no part thereof.

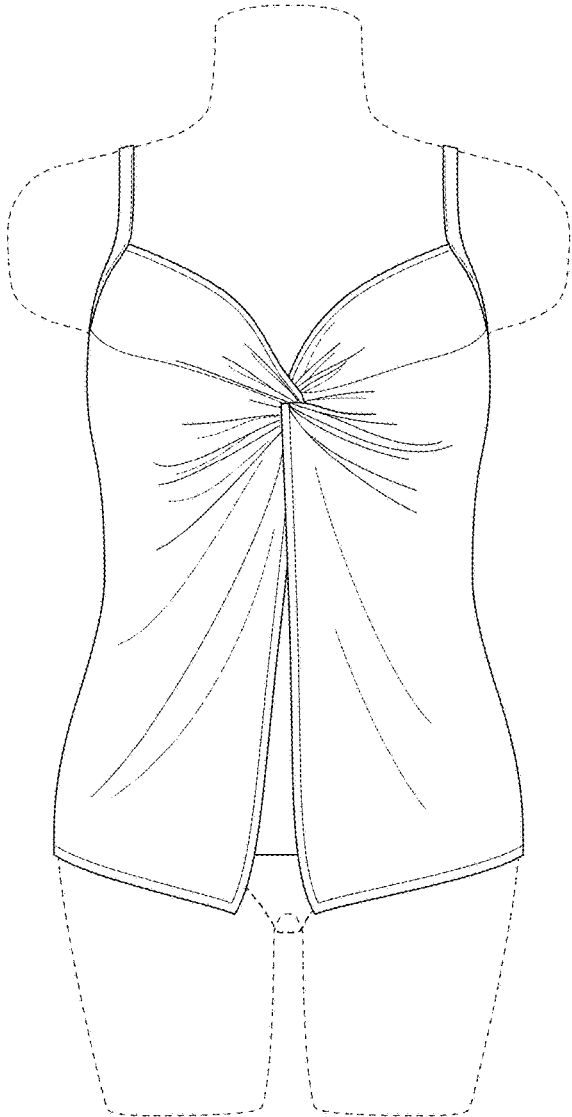

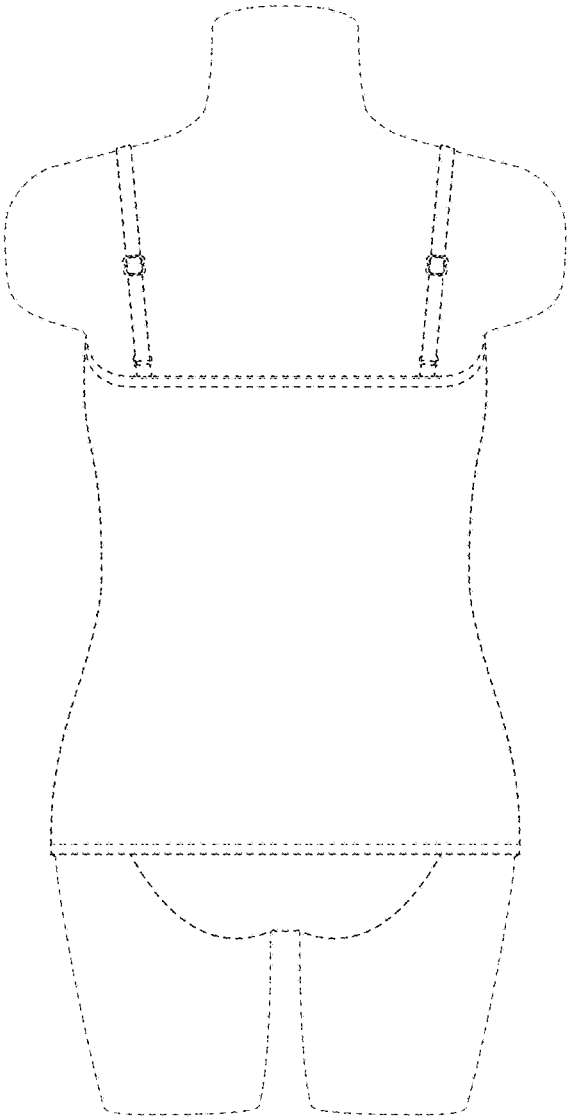

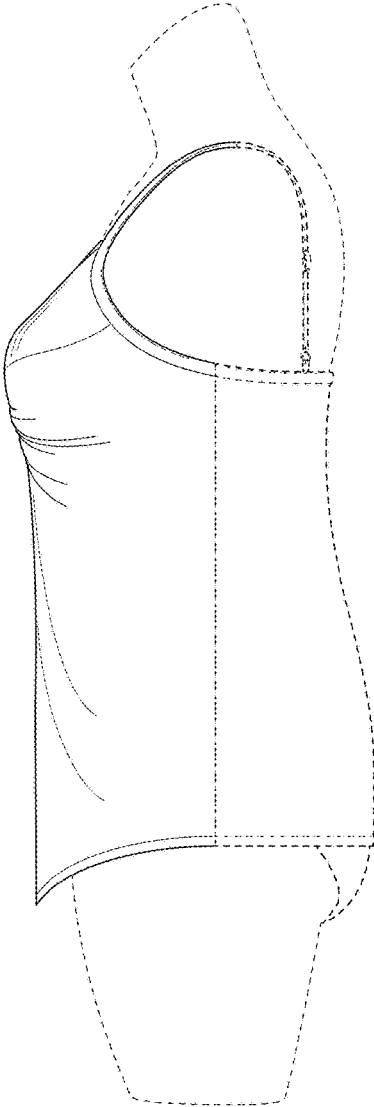

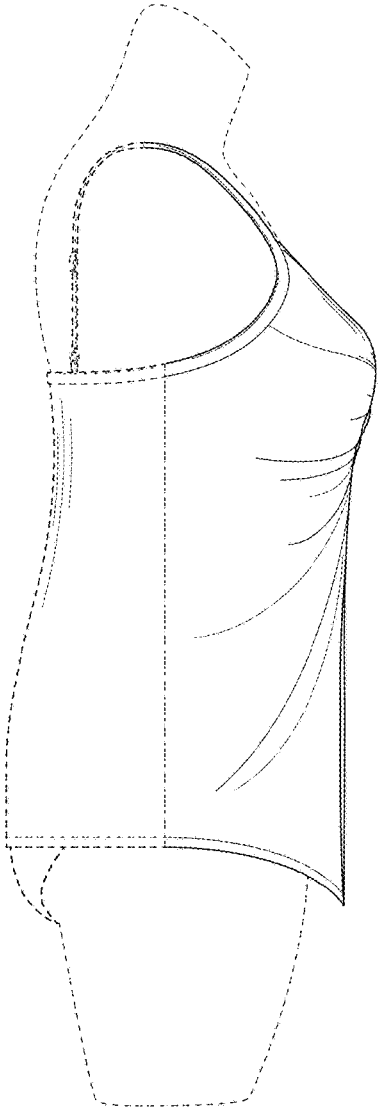
